The READ Center's mission is to help adults with low-level literacy develop basic reading and communication skills so they can fulfill their roles as citizens, workers, and family members. This mission is accomplished by providing: small classroom instruction, one-to-one tutoring and health literacy

In 2017-2018 academic year READ served 174 students and those students achieved 114 goals including citizenship, attaining a GED, getting jobs, driver's license, increased reading and writing skills, improved self-esteem, improved health and financial literacy and so much more. At the READ center, life and literacy progress go hand-in-hand. The READ center serves adults reading at between a 0-7 grade level. 75% of READ students read at or below the 5th grade level, while 47% are beginning readers and read at or below the 3rd grade level. Beginning readers are typically placed in classes, which meet twice each week for two hours each class and provide a structured learning environment. Students reading at a 4th grade or above level have basic reading skills and have the option to be paired with a 1:1 tutor. Pairs meet at least once a week for two hours. In 2017-2018, 135 tutors gave 6,814 hours of time to support READ Center students in classes and 1:1 tutoring. Classroom tutor/student pairings support work on lessons and provide customized instruction to help students make progress on their goals. 1:1 tutors work with students. Tutor training includes an hour of online training and 8 hours of orientation and classroom instruction. Tutors observe in classrooms or 1:1 pairs before graduating to work with students. Professional development on adult literacy topics is offered throughout the year.
