Virginia Community Voice is a 501c3 nonprofit, incorporated in February 2019. The organization received tax-exempt status from the IRS on June 12, 2019. Virginia Community Voice will file a 990 in early 2020.

Before Virginia Community Voice became an incorporated entity and 501c3 nonprofit, it was a program of another nonprofit organization, Thriving Cities Group. (The program was referred to as RVA Thrives.) In July 2019 RVA Thrives transitioned from Thriving Cities Group and became a program of a new entity called Virginia Community Voice.


Virginia Community Voice has two programs: RVA Thrives, and Community Voice Blueprint.

As a new 501c3 nonprofit, there is limited financial history for VACV as an entity. To fulfill the requirements of this grant application, a 990 for Thriving Cities Group has been provided, as this includes the expenses and revenue reported to the IRS for RVA Thrives programming in 2018.
