EACH HOMELESS SERVICE PROVIDER RECORDS CLIENT INFORMATION AND SERVICES PROVIDED TO THE CLIENT. ONCE THIS DATA IS ENTERED, CLIENTS ARE RELIEVED OF HAVING TO REPEAT THE SAME INFORMATION TO DIFFERENT PROVIDERS. EACH CASE MANAGER CAN ENTER CASE PLANS AND GOALS FOR EACH CLIENT AND FOLLOW UP ON ACTIONS TAKEN OR REFERRALS TO OTHER AGENCIES. THE INFORMATION IN THE DATABASE IS HIPAA-COMPLIANT AND CAN BE CLOSED ACCORDING TO THE WISHES OF THE CLIENT. DATA CAN BE AGGREGATED (AND DISASSOCIATED FROM CLIENT PARTICULARS) TO TRACK USE OF THE HOMELESS SERVICES SYSTEM, GAPS IN SERVICES, AND CHANGES IN USAGE PATTERNS. AS A SYSTEM, IT CAN BE DETERMINED IF THE EXISTING SERVICES ARE WORKING EFFICIENTLY AND EFFECTIVELY TO SOLVE THE PROBLEM OF HOMELESSNESS. HCIS IS THE LOCAL VERSION OF A NATIONALLY MANDATED HOMELESS MANAGEMENT INFORMATION SYSTEMS (HMIS).
