The Circles Program purpose is to give young men a variety of positive male role models who show up consistently and tell the truth about their struggles as men. We focus on young men aged 12-17 with an emphasis on middle school boys, as this is traditionally a time when boys are still impressionable and open to new ideas. Mentors help young men figure out what kind of an adult man he wants to be, praise him for his gifts, support him when he makes mistakes, and encourage him to make good choices on his path to manhood. The desire is for this to be learned from a positive role model verses someone on the street corner.

We assist the Families and provide Tutors for the Boys that need the extra help because of our whole child concept. Stepping up for the Boy's to minimize the stressors in their lives that shape and influence their decision making. Utilizing primarily a growing number of mentors and school professionals to assist us in these processes. Following the proven format of the circle program to remove outside influences and allow concentration to the task at hand. Helping the families ensures follow through on what we have taught outside of the circle and in the home.

The Rite of Passage Adventure Weekend, is the culminating event for Boys who have attended for the predominance of the school year in circle.
