Permanent Supportive Housing: Virginia Supportive Housing ("VSH" or the "Agency") owns, operates and manages eighteen residential properties in Central and Eastern Virginia. These buildings contain 463 units and are rented to either qualifying, low-income individuals or persons who have previously been homeless. To meet the needs of its residents, the Agency employs a support staff of 18 people. The social workers and case management staff provide the care and support to foster stability, wellness, recovery and independence of the residents. During 2015, a total of 408 formerly homeless individuals were housed and served in the properties owned by VSH. In 2014, more than 97% of the clients served by the Permanent Supportive Housing program did not return to homelessness.

Scattered Site Programs: VSH is the recipient of grants from the U.S. Department of Housing and Urban Development ("HUD"), as well as the Department of Veterans Affairs (the "VA"). These programs provide housing subsidies and assistance for qualifying individuals who reside with third-party landlords. The Agency employs a support staff of 33 people to meet the needs of the individuals served by these programs, as well. The Agency administers four programs funded by HUD, while one program is underwritten by the VA. In South Hampton Roads, 104 individuals were served by the Housing Stabilization Team of the Housing First program which serves clients from outreach through housing stabilization. Housing First focuses on individuals with a history of chronic homelessness and strives to stabilize them and increase their independence. HomeLink is a program in the Greater Richmond area which See Form 990, Page 2, Part III, Line 4b (continued)

Property Management: VSH manages 463 units under the Permanent Supportive Housing program, which includes supportive studio apartments, community houses, and quads. Residents in these independent living communities, typically pay one-third of their income as rent. All properties managed by VSH have passed federal, state and local government reviews and inspections, as well as compliance and property audits required by its lenders or funding sources. VSH is also a certified Property Management Agent by the Virginia Housing and Development Authority.

provides affordable rental housing and intensive case management to single adults with disabilities. These individuals have typically experienced extended or repeated episodes of homelessness. A total of 96 clients were served by the HomeLink program in 2015. The "A Place to Start" or ("APTS") program provides affordable rental housing and intensive clinical services to chronically homeless individuals who have severe and persistent mental illness. The VSH staff members assigned to APTS, referred to as the Intensive Community Treatment Team, are available on a 24-hour per day, 7-day per week basis and include the services of a psychiatrist. During 2015, 75 clients were helped by APTS. The Agency's Shelter Plus Care program served 195 people in 131 households in the Greater Richmond area during 2015. The program provides rental subsidies, while support services are outsourced to partnering agencies. VSH also administers the largest and longest-running VA-sponsored assistance program in Central Virginia. Entitled Support Services for Veteran Families (or "SSVF"), is a program that provides rapid access to rental housing for veterans experiencing homelessness, while also assisting veterans who are in danger of losing their housing. SSVF assisted 563 individuals during 2015.
